WAIVER, ASSUMPTION OF RISK, CONSENT AND RELEASE OF LIABILITY**

\_\_\_\_\_ (“Child”), an enrolled participant (“Participant”) in the Fundamental and Life Skills Sports Camp (“Program”) being conducted at Essex County West Side Park, Newark, New Jersey, Essex County Irvington Park, Irvington, New Jersey and Essex County Watsessing Park, East Orange, New Jersey (“Park”) owned and operated by the County of Essex, in consideration of the Child’s enrollment and participation in the Program hereby execute this Waiver and Release of Liability on behalf of myself and the Child. I understand that participation in the Program involves the risk of inherent dangers associated with physical exertion and with the sport of football and basketball, including but not limited to injuries associated with physical fitness like muscle sprains or strains, contusions, cuts, abrasions, dislocation of joints, and broken bones. Nonetheless, in full knowledge of the risks associated with participation in the Program, I expressly and knowingly, freely and voluntarily, accept and assume all risks involved in and associated with my Child’s participation in the Program, and waive any and all rights I and/or my Child may have to recover for any injury he/she may sustain or for his/her death resulting or arising out of his/her participation in the Program. Accordingly, on behalf of myself, my spouse and my Child, and our respective heirs, assignees and successors in interest, I waive, release indemnify and hold harmless the Fundamentals and Life Skills Sports Camp and the County of Essex, its elected officials, officers, employees, agents, and representatives, the Program and its sponsors, employees and agents and their respective heirs, successors and assignees, from and against any and all claims, demands, injuries, damages, actions or causes of action, and from all acts of active or passive negligence on their part, that I or my Child may have or acquire against them or any of them on account of death, bodily injury or mental injury from, any mishap, accident, loss, damage, or injury sustained by the Child as a result of/or arising out of his/her participation in the Program. As a parent/guardian of the aforementioned Child, I hereby agree to personally provide and be responsible for any and all future medical expenses which may be incurred by the Child as a result of any injury sustained by him/her while participating in the Program.

I understand that in the event of an emergency, every reasonable effort will be made to contact me, but in the event I am not able to be reached, I hereby consent and give permission to the Program and their respective employees, agents and representatives, to act for and in my behalf according to their best judgment to secure appropriate medical treatment for the Child. I hereby consent and grant the Fundamental and Life Skills Football Camp the right without further authorization or payment to videotape or photograph my Child solely for the purpose of promoting activities of the Program. I further agree to release and discharge the Fundamental and Life Skills Sports Camp, their clients, companies, all directors, officers, agents, employees, representatives from any and all damages, actions, cause of actions, suits, claims, and demands arising in connection with my Child’s performance in this video/photograph to be used as described above. I represent that I am competent and have the unrestricted right and capacity to enter into this Consent and Release agreement, to grant the Fundamental and Life Skills Sports Camp and their respective companies and clients the rights granted herein and to release the claims released herein.
